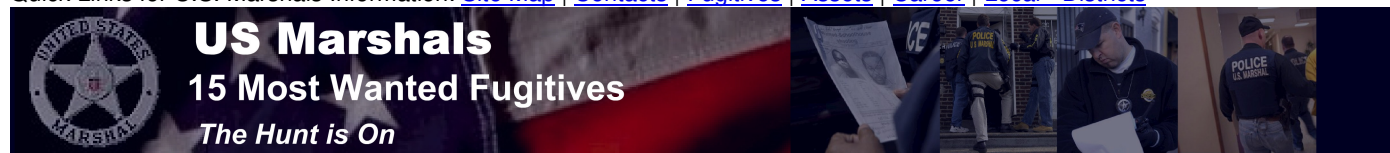

U.S. Marshals Add Convicted Bank Robber to 15 Most Wanted List: The United States Marshals announced here today that the agency has added [Anthony "Tony" Ray Artrip](#) to its list of 15 Most Wanted Fugitives. Artrip, 35, of Ashland, KY, is wanted by U.S. Marshals in the Eastern District of Kentucky after escaping from the Grant County, Kentucky Detention Center, on June 24, 2007. On that evening, Artrip escaped through the roof of the prison facility and fled through a wooded area on foot. He was in jail awaiting sentencing in federal court for three counts of bank robbery, following a conviction in Ohio. [Read More](#)
